#### **I. Call to order**

Lt. Governor Hall-Long called to order the 6th regular meeting of the Behavioral Health Consortium at 11:07 AM at Delaware Public Archives, Dover.

#### **III. Story of Recovery**

Kim Jones, intake specialist at Gaudenzia, who is in long-term, active recovery shared her story and the impact addiction has had on her. More specifically, Ms. Jones shared the importance of quality rehabilitation services and community supports.

#### **IV. Legislative Update**

Dr. Rattay provided an update on the following pieces of legislation: Overdose System of Care (HS 1 to House Bill 440), Pain Management Treatment (Senate Bill 225), and Prescription Monitoring Program (Senate Bill 206). She expressed support and optimism in the passage of these three pieces of legislation by the conclusion of Legislative Session.

Carolyn Petrak provided an update on the Mental Health Parity (Senate Bill 230) and expressed support of the legislation, Furthermore, optimism of the passage of Senate Bill 230 was expressed by the conclusion of Legislative Session.

#### **V. Committee Structure**

The Lt. Governor provided an overview of the committee structure and instructed the public to reach out to staff if individuals are interested in serving a specific committee. The Lt. Governor further stated that committees will take some time to establish, but once formed the majority of the Consortium's ongoing work will be led by committees.

The Lt. Governor informed the Consortium that within the coming weeks and month, members of the Consortium and public would be contacted by staff to participate on specific committees.
