 - i. Currently 305/5staff throughout the program—116 active MAT patients.
 - ii. Address barriers to treatment through multiple modalities
 - b. Pathways to Recovery
 - i. Part-hospital, short-term (40-45days).
 - ii. Includes individual, family therapy and MAT
 - iii. 121 completed survey
 - c. Forensic Intensive Recovery (FIR)
 - i. Community based services and case management.
