#### **V. Johns Hopkins Report**

Dr. Broaden Saloner, from Johns Hopkins' Bloomberg School of Public Health, presented a report titled: *A Blueprint for Transforming Opioid Use Disorder Treatment*

Governor presented an update on Senate Bill 230 (Mental Health Parity), House Substitute 1 for House Bill 440 (Overdose System of Care), Senate Concurrent Resolution 78 (Veterans Response Team resolution), and Senate Bill 225 (Pain Management). Lt. Governor Hall-Long also spoke about upcoming bill signings and the \$5 million allocated to the Consortium's recommendations.

## **VIII. Pew Charitable Trusts**

The Pew announced that they are entering a partnership with the Consortium and provided an update to members.

## **IX. DOMIP Mapping App**

Dr. Tammy Anderson, of the University of Delaware's Center for Drug and Health Studies, presented an update on Delaware's Opioid Metric Intelligence Project (DOMIP). This interactive mapping system was unveiled to the Consortium.
