III. Story of Recovery

Ms. Becky King, a Consortium member and mother of an individual in long-term recovery, shared her personal story and the impact addiction has had on both her family and daughter's life.

V. Delaware Electronic Treatment and Referral Network

Ms. Elizabeth Romero, Director of the Division of Substance Abuse and Mental Health, introduced the new Delaware Electronic Treatment and Referral Network to the Consortium. Ms. Romero's consulting firm, based in Washington D.C., demonstrated

the OpenBeds software and provided context to how the system will ensure expedited treatment for those in active addiction and seeking a treatment bed.

VI. Delaware Human Trafficking Interagency Coordinating Council

Dr. Leslie Brower, of the Division of Substance Abuse and Mental Health, and Yolanda Schlabach, Executive Director of Zoë Ministries, Inc., presented the work of the Delaware Human Trafficking Interagency Coordinating Council. Ms. Schlabach informed the Consortium of the current trafficking trends in Delaware and the impact trafficking has on our vulnerable populations throughout the state. Ms. Schlabach asked to have the presentation included in the official record and was done so without objection.

VII. Suicide Prevention Coalition

Ms. Susan Cycyk provided an update on the Suicide Prevention Coalition, which included the Coalitions' key objectives. Ms. Cycyk informed the Consortium that the Coalition is working in partnership with the Mental Health Association of Delaware and continue to stress the importance of data surveillance.

The Lt. Governor informed the Consortium that the Governor has now signed all Consortium supported legislation. The Lt. Governor also informed the Consortium that the six committees, through their work, would develop legislative and policy recommendations, which will come before the full Consortium for further review and potential support.
