- Statewide EMS/Paramedic Buprenorphine and Suboxone induction program.
- Extended Pharmacy Hours
- Substance Use Treatment CEU's for Treatment Providers
- Naloxone distribution by county

Addiction Action Committee

- Official Relaunch Meeting in October.

Corrections & Law Enforcement

- Individuals released not receiving medication allowance of 30 days.
- Individuals incarcerated not considered 'homeless' until they are officially released, aiming to resolve issue to find housing before release.
- Crisis management incorporation in police departments.

Data & Policy

- HB 160 passed 6/28/2023: act provides framework to maximize the benefits of 988 (suicide hotline) through the implementation of a practical, modern, comprehensive, and integrated crisis care system.
 - SB 52 passed 6/29/2023: Act to amend title 29 relating to sterile needle and syringe exchange program.
 - HB 114 passed 6/30/2023: Act to amend titles 16 and 25 of code relating to recovery housing.

- HB 4 passed 6/29/2023: Act to amend title 14 of code relating to mental health services for school trauma.

Harris Marx: Son has schizophrenia and suggests a policy change that requires such individuals to be handcuffed during transportation to hospitals or between health care facilities.

Marc Briggs: What is the process of reallocating funds to a different applicant who was not funded if funds are refused or not awarded for cause?

Sparkels: Are there only 3 levels of funding available?

- Focus areas are set for the first year, other levels will be available in future.
